"Your new PC is here"

As we all know getting a new PC is something that can be both good and bad for some people.

The Good:

It will replace an aged system that more than likely is way past its useful service life.

We use our computers here at work every day and need stability and speed. A new PC can give you that.

It has updated hardware inside which on average is roughly 1-3 generations above what your old PC had.

More RAM is used today as we multitask more. The new PC has more, and the RAM is faster. Updated Operating Systems today are more compatible with newer software being developed.

The Bad:

Depending on your current system you will see a big change in how things look.

The jump from Windows XP to Windows 7 is a bit awkward for some people. We all used windows XP so long and memorized every little thing about it. Windows 7 is surely different, and it throws a lot of users into panic mode. With time however users find a flow with Windows 7. Then we have The BIG change. If your current system used Microsoft Office XP or Office 2003 then you will definitely be shocked to see Office 2010. It is a total alien looking application at first glance to users familiar with older versions. All of our familiar little buttons and labels up top are gone! Why did Microsoft do this? What is this? I've heard this quite a bit. It is very different to the eye and also to the mouse clicking finger that has been trained for years.

I'm sorry to say we are stuck with it, and believe me when I say I feel your pain.

The link below has free tutorials and general information on Office 2010. Think of this as something to take for your Office 2010 headache. It will help you get a general idea of what has changed. Sometimes I get random questions or run into certain things. I will try to list some more common things

people have asked me about:

Q: What is the difference between x86 and x64 versions of Microsoft Windows?

A: Visually they are identical. In function to the user they are identical in most cases. The x86 version is a 32bit Operating system. It can address and use up to 3GB of System RAM. It runs in a 32bit mode. The x64 version is a 64bit environment and addresses RAM sizes in excess of 3GB. The x64 version can also run all x86 software. That is why in a lot of cases you see the Program Files (x86) directory on your C: Drive. Even though it can run 32 bit programs that does not mean your particular software is 100% compatible with the x64 version.

Q: What antivirus program can I use at home that is free yet effective?

A: There are quite a few "free" anti-virus packages around these days. Below are the names of some that are fairly good and have gained some good reviews and test results. They offer active protection in addition to manual scan capability.

Avast Free Antivirus
Avira

There are also online virus testing sites. Say for instance you downloaded a small file and want to test it against your current antivirus. <http://virusscan.totti.org> and <http://www.virustotal.com> are two I'm familiar with.

Two other programs that can help you once infected are Malwarebytes Anti-Malware and Super-antispyware. They detect and remove malicious programs from your PC. Some infections however can only be fully removed with a total disk wipe, OS reload, and software reload. In addition a lot of internet providers these days offer a free subscription of Antivirus software to new customers. Check the help section of your ISP's site or ask them.

Q: I'm looking to get a new PC or laptop. What should I look for spec-wise?

A: Everyone's needs are going to be different as well as their budget. A lot depends on those two factors. As a bare minimum for desktops here are the specs I find useful: 3ghz+ CPU Dual Core (Quad Core is even better) 500GB 7200RPM Hard Drive 3.5" form factor SATAII (SATAIII is

better but more costly in some cases) 80+0% Efficiency Power Supply 4GB RAM with x64 Operating system (8GB is even better) DVD-R/RW Drive (Bluray more future proof but is costly) 3yr warranty Office Software if applicable 21.5" or 22" LCD Monitor OS, Driver, and Apps Media (is a charge now for this, but well worth it)

Laptops:
2.6ghz dual or quad core
500GB Hard Drive 5400RPM
SATAII (7200RPM if you can get it)

4GB RAM with x64 Operating system (8GB is better)

3 yr warranty
Accidental Damage Warranty is optional and costly but protects you against spills and other accidents

Office Software if applicable
15.6" screen (17" is better but adds extra cost and size)

OS, Driver, and Apps Media (is a charge now for this, but well worth it)

DVD-R/RW Drive (Bluray more future proof but is costly)

A carrying Case

If funds permit it, buy a battery that has more "cells". This adds more battery run time.

Also buy the higher wattage power adapter/charger if you buy the large battery.

What to avoid when buying a new unit:

"El Cheapo" bundled systems from a large retailer. Systems that cost \$400 are a good example. They often come with low end everything and little (90 days) warranty. In the end, it really isn't worth it. These are throw away systems at best so don't expect much service life from them. If your budget can only afford one of these systems then by all means buy an extended warranty if it is less than \$79 and offers you 2-3 years extra.

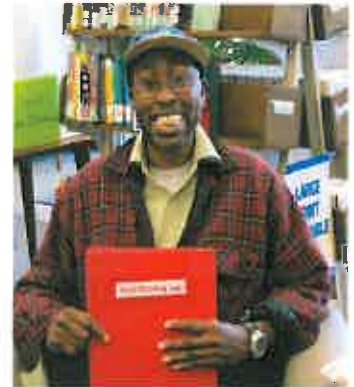
help in the garden or donating plants / materials, just contact the library at 694-6241!

Skillet Corn Bread

This is the corn bread that I make in my big, heavy skillet. First I get that thing real hot and swirl in my grease, then I pour in the batter and it forms a great, golden crust right off the bat.

MAKES ONE 9-INCH ROUND

¼ cup lard or vegetable shortening
1 teaspoon salt
2 cups fine yellow cornmeal
1 cup buttermilk
2 teaspoon baking powder
2 large eggs
1 teaspoon baking soda

1. Preheat the oven to 400F. In a 9-inch cast-iron skillet, melt the lard or shortening over medium heat. Swirl the melted fat around the sides of the pan to coat it all over.
2. In a large bowl, whisk together the cornmeal, baking powder,

baking soda, and salt. In a small bowl, whisk together the buttermilk and eggs. Using a rubber spatula, fold the buttermilk mixture and the melted lard or shortening into the flour mixture. Gently mix to combine.

3. Scrape the batter into the skillet. Bake until light golden brown and firm to the touch, about 25 minutes. Cut into wedges and serve warm or at room temperature.

Jordan Lake Fact Sheet

The Jordan Lake Rules are a nutrient management strategy designed to restore water quality in the lake by reducing the amount of pollution entering upstream. Restoration and protection of the lake is essential because it serves as a water supply for several thriving communities, as well as a prime recreation area for more than a million visitors each year. The lake and surrounding forests also provide critical habitat for many plant and animal species.

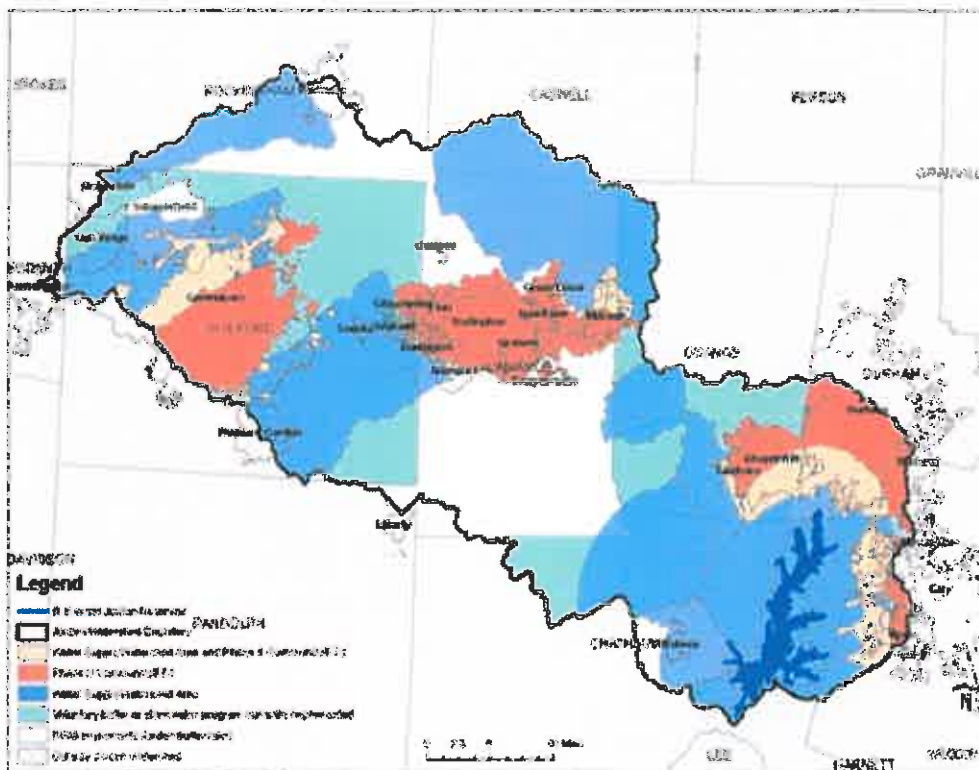
Jordan Lake was impounded in 1983 by damming the Haw River near its confluence with the Deep River. It was created to provide flood control, water supply, protection of water quality, downstream, fish and wildlife conservation, and recreation.

The lake has had water quality issues from

the beginning, with the North Carolina Environmental Management Commission declaring it as nutrient-sensitive waters (NSW) the same year it was impounded. Since that time, Jordan Lake has consistently rated as eutrophic or hyper-eutrophic, with excessive levels of nutrients present. The Jordan Lake Rules are designed to protect and improve water quality in the lake. The rules were developed over several years through a process that involved extensive meetings, public hearings and negotiations between residents, environmental groups, local and state government agencies and other stakeholders in the watershed. Specific issues addressed by the rules include reducing pollution from wastewater discharges, stormwater runoff from new and existing development, agriculture and fertilizer application.

As you can see in the below map approximately 10% (43 square miles) of Caswell County is affected by the Jordan lake Watershed rules. Caswell currently has the required "Buffer Protection Ordinance" in place and is in the process of completing the "New Development Ordinance" once NCDENR (North Carolina Division of Environment and Natural Resources) finishes their review. When the "New Development Ordinance" is adopted it will require most development activities in the area that disturb one-half acre of land to submit Stormwater Management plans to the County. Captain Scott Halbrook was awarded the Advanced Deputy Professional Law Enforcement Certificate by The North Carolina Sheriff's Education and Training Standards Commission on March 21, 2012. Captain Halbrook was also awarded the Advanced Service Award. Captain Halbrook was approved for this award for a total of 20 years of criminal justice service. The North Carolina Sheriff's Education and Training Standards Commission was established in September 1983. The purpose of the North Carolina Sheriff's Education and Training Standards Commission is to upgrade the capabilities, competence, and procedures involving employment, improvement career development, and retention of the sheriff's office personnel. The purpose of the Advanced Deputy Professional Law Enforcement Certificate is to recognize the level of competence of sheriffs and deputy sheriffs serving North Carolina Sheriff's Offices, to foster increased interest in college education and professional law enforcement training and to attract highly qualified individuals into a law enforcement career. The Advanced Deputy Professional Law Enforcement Certificate is the highest professional certificate awarded to sheriffs and deputy sheriffs in North Carolina. To qualify for the Advanced Deputy Professional Law Enforcement Certificate, sheriffs and deputy sheriffs must complete a combination of professional training and relevant education, as well as, meet minimum experience requirements.

Paula Seamster, Clerk to the Board of Commissioners, graduated on April 20, 2012 from the 2011-2012 County Administration Course from the School of Government, University of North Carolina Chapel Hill. The program in County Administration is designed for managers, department heads, and officials whose responsibilities require a broad understanding of functions beyond individual areas of specialization. The course was approximately 150 hours in length, and more than 60 instructors participated in leading the program. Course instruction covers North Carolina local government law, organization and management, finance and budgeting, employment law and administration, planning and regulation of development and the delivery of specific city or county services. Paula was one of 30 officials who graduated the course this year and is one of more than 2,800 officials who have completed the course since it began in 1964.

Tax Office

Real estate tax bills are due September 1 of each year and become delinquent on January 6 of the following year, the bills are mailed out the last week of August. 2012 real estate tax bills are due September 1, 2012 and become delinquent on January 7, 2013, since the 6th falls on a Sunday in 2013. The Finance Office in cooperation with the Tax Office has made arrangements to set up payment plans for county employees. The payment plans will be payroll deductions for monthly installments. County employees that wish to enroll in this payment plan should contact the Finance Office by August 1st of each year. Hopefully this plan will prevent the Tax Office from the need to garnish wages or attach bank accounts for unpaid

taxes by county employees. One or both of the collection procedures for county employees will take place on January 8, 2013 for any unpaid taxes on that date. Please make arrangements for all county taxes to be paid in full by the due date to avoid collection procedures.

County vehicle bills will be undergoing a change in July, 2013. At the present, when you renew or put tags on a vehicle you receive a tax bill in four months, that bill becomes delinquent after 30 days. Four months after the bill is due and the taxes have not been paid a block will be applied against that tag with the NC Division of Motor Vehicles and the tag will not be able to be renewed until the tax are paid and the block has been removed. Beginning in July, 2013 the tax will be paid at the NC Division of Motor Vehicles when you renew

the tag or put new tags on a vehicle. Please make arrangements to have all delinquent vehicle bills paid before this new law goes into effect to avoid complications on current vehicles at the NC Division of Motor Vehicles office.

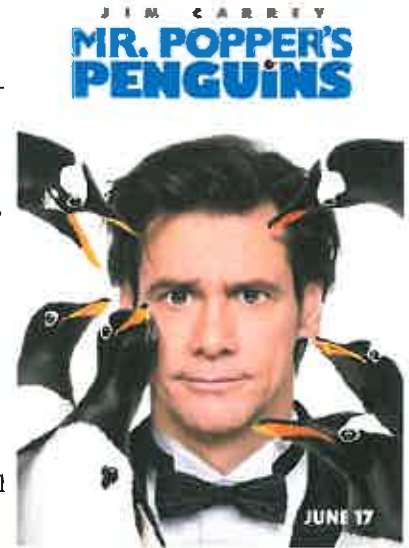


Movie Review: (DVD check outs from the library are free for 1 week)
