Caswell County Public Library ranked 11th in NC in Program Attendance!

The Guntz Memorial Public Library was ranked 11th in program attendance per capita out of all the public libraries in North Carolina!

As program attendance grew to the point of exceeding the library's facility, the Friends of the Library stepped in to rent space at the Caswell County Civic Center for the Summer Reading Programs. Summer Reading Programs at the Civic Center have held more than 220 patrons for just one program. As Becky explained that, "There were over 800 children signed up for the 2012 15 summer reading program. The value of library programs is priceless, providing children with pre-literacy skills, social skills, and develops a life-long love of reading."

Some of the library's regularly scheduled children's programs include

- Lambs and Lions - Wednesdays at 10:00 am - ages 0 - 5
- Book Baggers - Tuesdays at 3:30 pm - age 6 - 12
- Summer Reading Programs (June - July) Thursdays at 10:00 am - All ages
- Daycare Story Time - Tuesday mornings at 10:00 am
- Special Needs Classes (BY and Dillard) - Thursdays

In addition to the children's programs, other library programs include various basic computer classes, teen programs, poetry readings, local author talks, and story-telling workshops. The library is also in the process of developing an adult



literacy class (if you know of anyone that might be interested in these classes, please contact the library at 336-694-6241).

GMPL offers free library cards to all Caswell County residents and people living within a 50 mile radius of the county. In addition to traditional library materials available for check-out, which include books, magazines, newspapers, DVDs, and audios, the library also offers numerous other services: Faxing, coping, scanning, color printing, genealogy resources, outreach meeting room, download

ebooks, exam proctoring, and access to free public computers and WiFi are also available.

When compared to much, much wealthier counties (including counties with budgets more than 100 times that of Caswell County) GMPL is proud to hold a high ranking in program attendance!

A Proud Veteran

Fred A. Smith joined the United States Marine Corps September 28, 1966 and served until September 27, 1969. He was in the 1st Marine Division, 3rd Amtrac Battalion and served from March 27, 1967 through April 18, 1968 in Vietnam. Smith received two purple hearts while in Vietnam and received rank of Sergeant before leaving Vietnam.

Mr. Smith is currently the VFW Post Commander of Post 7316 in Yanceyville; he is also a member of the local American Legion Post 89, member of the Disabled American Veterans, member of the Marine Corps League. He is serving on the North Carolina Commission for Military Affairs Board, appointed by State Senator Berger, Majority Leader of the North Carolina Senate.

Mr. Smith is a member of the Caswell County Senior Advisory Board and is in charge of the Memorial Day and Veterans Day Ceremony held at the Historic Courthouse.

He is married to Sallie Gibson Smith who is retired from the Caswell County Finance Dept. They have two sons, Rodney and Chad.

Protect Your Pet During Winter and Cold Weather

Follow our tips to keep everyone safe and comfortable

In many areas, winter is a season of bitter cold and numbing wetness. Extra precautions during winter months will make sure your four-footed family members stay safe and warm.

Help your pets remain happy and healthy during the colder months by following these simple guidelines:

Indoors and warm

Don't leave dogs or cats outdoors when the temperature drops. Most dogs, and all cats, are safer indoors, except when taken out for exercise. No matter what the temperature, wind chill can threaten a pet's life. Regardless of the season, shorthaired, very young, or old dogs and all cats should never be left outside without supervision. Short-coated dogs may feel more comfortable wearing a sweater during walks.

The best way to keep your pets safe (and happy) is to keep them with you

If your dog spends a lot of time outside

A dog or cat is happiest and healthiest when kept indoors. If for some reason your dog is outdoors much of the day, he or she must be protected by a dry, draft-free shelter that is large enough to allow the dog to sit and lie down comfortably, but small enough to hold in his/her body heat. The floor should be

raised a few inches off the ground and covered with cedar shavings or straw. The house should be turned to face away from the wind, and the doorway should be covered with waterproof burlap or heavy plastic.

Keep feral and stray cats warm

If there are ferals or strays in your neighborhood, remember that they need protection from the elements. It's easy to give them shelter.

Keep the water flowing

Pets who spend a lot of time outdoors need more food in the winter because keeping warm depletes energy. Routinely check your pet's water dish to make certain the water is fresh and unfrozen. Use plastic food and water bowls rather than metal; when the temperature is low, your pet's tongue can stick and freeze to metal.

Be careful with cars

Warm engines in parked cars attract cats and small wildlife, who may crawl up under the hood. To avoid injuring any hidden animals, bang on your car's hood to scare them away before starting your engine.

Safety and salt

The salt and other chemicals used to

melt snow and ice can irritate the pads of your pet's feet. Wipe all paws with a damp towel before your pet licks them and irritates his/her mouth.

Avoid antifreeze

Antifreeze is a deadly poison, but it has a sweet taste that may attract animals and children. Wipe up spills and store antifreeze (and all household chemicals) out of reach. Better yet, use antifreeze-coolant made with propylene glycol; if swallowed in small amounts, it will not hurt pets, wildlife, or your family.

Probably the best prescription for winter's woes is to keep your dog or cat inside with you and your family. The happiest dogs are those who are taken out frequently for walks and exercise, but kept inside the rest of the time.

United Way of Caswell County—Frequently Asked Questions By Shannon White

What is United Way of Caswell County?

United Way is a nonprofit, 501(c)(3) agency that brings people and communities together to advance the common good. We partner with local nonprofits, businesses, government and social service agencies to address our community's most pressing needs.

Our mission is to mobilize the community by helping people take collective action to create positive, lasting change. We do this by fundraising for local agencies and taking a leadership role in coordinating local initiatives.

Who are your member agencies?

UWCC does not have member agencies, but instead allocates funds raised through a competitive grants process. During our last allocations cycle, we awarded a total of nearly \$15,000 to the following agencies working in Caswell County: Caswell County Senior Center; Caswell County Partnership for Children; Caswell Parish, Caswell 4-H; Caswell Family Medical Center; and the Old North State Council, Boy Scouts of America.

I didn't know we had a United Way, how long have you been here and where has the money come from?

UWCC was formed by an all-volunteer board of directors in 1992. Over the past decade, the majority of the money raised has come from employees working outside of Caswell County, contributing to workplace campaigns held in those counties.

I've heard United Way spends a lot of money on salaries and other administrative cost. Is that true?

Nearly twenty years ago, there was a scandal involving excessive salaries and expenses for a top executive at United Way of America (now United Way Worldwide) and executives at large United Way agencies across the country. That UWA executive spent 7 years in prison for his actions and United Ways changed the way they do business.

It's important to note that currently United Way of Caswell County does not have any paid staff. The organization is run entirely by a volunteer board of directors and volunteer administrator. UWCC is a member of the Caswell County Chamber of Commerce, United Way of North Carolina and United Way Worldwide. We pay dues to those organizations, as well as a post office box rental, postage and accounting fees. For every dollar we raise, only 3 cents go to administrative costs, the other 97 cents goes to local agencies.

We've seen a lot of United Way lately, including campaign materials.

Who paid for that?

UWCC was fortunate to receive a year-long planning grant from the Danville Regional Foundation in July of 2011. That grant funded a temporary part-time planning coordinator to work with the agency to develop a plan to better meet the needs of Caswell County. It also provided funds for outreach materials, such as the campaign brochure and pledge form you have received.

What sort of plan did United Way come up with?

By working with local non-profits, community members and government agencies, UWCC has developed a plan to function as a central hub for the county. This hub is designed to increase local capacity by maximizing available resources through: initiative building; centralized community outreach, fund development (including grant writing) and program administration; training opportunities including board and staff development; volunteer recruitment; and, coordinated assessment and planning. The Hub will also serve as a central intake and referral point for Caswell residents seeking assistance based on a "no wrong door" philosophy that contends that residents should have access to all available community resources regardless of which agency they first encounter.

Wow, who is going to pay for that?

UWCC is currently seeking grant funding for that project.

Meanwhile...

The need in Caswell County is tremendous. There never seems to be enough time, money or people to meet that need. UWCC needs YOUR help to make a difference. Did you know that if every single person living in Caswell County gave \$1 a week, we would raise just over ONE MILLION DOLLARS to allocate to the local agencies who provide services to Caswell residents. Now THAT would make a difference!
