## FOR YOU, YOUR NEIGHBOR, AND YOUR FUTURE

The Community Emergency Response Team (CERT) concept was developed and implemented by the Los Angeles City Fire Department (LAFD) in 1985. The Whittier Narrows earthquake in 1987 underscored the area-wide threat of a major disaster in California. Further, it confirmed the need for training civilians to meet **their immediate needs**. As a result, the LAFD created the Disaster Preparedness Division with the purpose of training citizens and private and government employees.

The training program that LAFD initiated makes good sense and furthers the process of citizens understanding **their responsibility** in preparing for disaster. It also increases **their ability to safely help**

**themselves, their family and their neighbors.** The Federal Emergency Management Agency (FEMA) recognizes the importance of preparing citizens. The Emergency Management Institute (EMI) and the National Fire Academy adopted and expanded the CERT materials believing them applicable to all hazards. The CERT course will benefit any citizen who takes it. This individual will be better prepared to respond to and cope with the aftermath of a disaster. Additionally, if a community wants to supplement its response capability after a disaster, civilians can be recruited and trained as neighborhood, business, and government teams that, in essence, will be auxiliary responders. These groups can provide immediate assistance to victims in their area, organize sponta-

neous volunteers who have not had the training, and collect disaster intelligence that will assist professional responders with prioritization and allocation of resources following a disaster. Since 1993 when this training was made available nationally by FEMA, communities in 28 States and Puerto Rico have conducted CERT training.

A requirement to have a CERT Program is a certified program manager. Jeff Sizc attended this course of study in Raleigh. However, CERT Coordinator and Point of Contact for Caswell County is Mr. Barry Lynch, 336.694.5177 Ext 3. Please get involved, for yourself, your neighbor, and your future. ## Meals on Wheels Needs Volunteers

The Meals on Wheels program is a vital service that is a life source for some of our seniors here in Caswell County. Everyone knows of an elderly person who is unable to get out of the house to shop, or is too frail to fix a nutritious meal. In an ideal world, this individual would live with family and have their meals cooked for them. In today's world however that is not feasible and some older adults are going without regular meals. The Meals on Wheels program however serves purposes beyond just taking care of the food needs of an elderly person. It provides important human contact and serves as a safety net in the event a person has fallen ill.

The Meals on Wheels program is dependent upon volunteers to work. The Caswell Senior Center administers the program and currently 145 people volunteer each month to serve 117 needy seniors. We have recently lost several volunteers and when they are not replaced, the seniors receiving the service go without. Many volunteers deliver one route a month – think of it as giving up one lunch hour to help approximately ten people. Actually, I am asking you to give up one lunch hour a month to help the seniors in the county. The meals are delivered from the Senior Center at 10:00 am. Is your work schedule flexible? Can you switch with someone to get your work covered? Not

every day, just once a month! Volunteers receive a brief orientation and are accompanied by an experienced staff member on their first delivery. If this sounds like something you can do, please seriously consider it. You do use your own vehicle and gas and you do give up a bit of your time. But remember, you get more back in the form of thanks from the seniors you will be helping! **Story Time!**

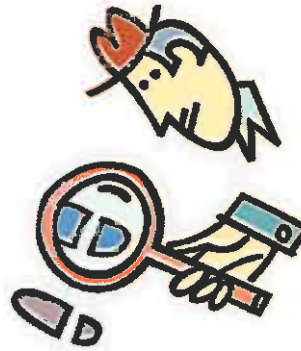
Story Time and Book Baggers Programs will start up again in September!

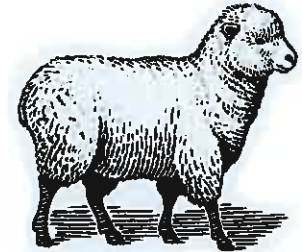

Power Considerations

We live in an electronic device era. Electronic devices are everywhere around us and we use them daily. Many items today that aren't specifically computers still have digital computerized parts inside. And then we have the computers and related items that are even more sensitive. In the warmer months of the year storms do happen and of course lightning damage is a real concern. Lightning damage is not the only killer of electronics. Brownouts and power sags with "flickering" of the power also present a problem. There are some devices that are even more sensitive than others.

Wireless Routers, Cable/DSL modems, or any network device. The slightest blip in power will cause them to have problems. The issue can usually be corrected by unplugging the power, wait 10 seconds and then re-plug. While this will most of the time fix the problem it can be annoying, not to mention potentially damage the device.

So what to do to protect my investment?

- 1) Use surge protectors. This is a minimum requirement of most electronics. It's just common sense.
- 2) Use a UPS (Uninterruptable Power Supply) on sensitive or critical/expensive devices.
- 3) When a storm is nearby and you see a lot of lightning, unplug the device from the wall and phone/cable/dsl line.

Surge or UPS-How to determine and select the proper equipment:

Surge Protectors are going to be a very basic protection to protect your connected devices from surges or spikes in voltage. Surge Protectors come in different varieties but the most important aspects of selecting a good one are the following:

**Clamping Voltage: Do Not buy one that has higher than 400v for this rating.**

**Joule Rating: 400 as a minimum, 600+ is better**

**Response Time: Try to find one that lists 1ns or less**

If you are looking at a surge protector that does not list numbers for the above items, move on until you find one that does.

When To Use a UPS and what to select:

A UPS is a device that contains a battery and can power your devices a short amount of time on that battery by converting it into AC voltage. A UPS is not a cheap undertaking in most cases. The good ones cost and are to be considered an investment, but money well spent in the right situation. So what to look for in a UPS?

The VA Rating is what most companies push. The wattage rating is very important too. Most UPS's have built in surge protection as well as a "connected device guarantee" clause that provides a certain monetary amount for anything damaged. Some rating guidelines for certain

devices at your home: 400VA and less -Wireless Routers, Cable/DSL Modems, Firewalls, Switches, cordless phone base. 900VA to 1500VA- Desktop PC and Monitor.

These are merely general guidelines. When buying a UPS always buy the most VA rating you can afford at the time. A lot of UPS devices today also come with software that you install on your PC that shuts your system down safely when the UPS kicks in for a amount of time. A small cable connects to the UPS and your PC and they communicate this info.

Last Thoughts

Some surge protectors and UPS devices have built in phone line or ethernet surge protection. Use this at your own risk, as a lot of times these will cause issues. Granted some are good but the lower cost units usually have sorry implementations of these things and reduce your signal strength. You can try it, but if you notice your internet connection dropping out intermittently unplug it. As for a phone line, a dedicated protector of that type can be installed by your phone company inside your telco box at your residence.

*CIGNA Co-pay Announcement*

The Caswell County Health Department has recently become a participating provider with CIGNA health insurance. This means that county employees that use CIGNA can now receive basic health care services at the Health Department and have them covered by CIGNA. In an attempt to encourage county employees to take advantage of this service, the Board

of Health has allowed us to waive the co-pay requirement starting September 1<sup>st</sup>. You will still be responsible for your deductible and what CIGNA does not pay but you will not be required to pay the co-pay. While we can also provide services to your family members with CIGNA, the co-pay will only be waived for employees.

The Health Department sees patients by appointment and you can usually be seen within a few days of calling. If you are interested in receiving health care services at the Health Department, please call 694-4129 extension 144 to set up an appointment.

**In the next few weeks the Board of Elections office will move. The new location will be 140 Main Street.**

Now is the time to register to vote or to update your current voter registration. The deadline for new registrations and changes is *October 12, 2012*. If you have moved or changed your name since you last voted please contact the Board of Elections office to make sure your voter registration is current.

The General Election is coming up on **Tuesday, November 6, 2012**. Some important dates to note pertaining to this election are as follows:

**Friday, September 7, 2012** – First day to request absentee ballots by mail. If you have an elderly or disabled parent or grandparent or a child away at school you can request an absentee ballot for them. A ballot will be mailed to them

with a special return envelope.

**Friday, October 12, 2012 5:00 pm** – Voter registration deadline for November 6 General Election. Forms must be postmarked or delivered in person by 5:00 pm today. \*Individuals who miss the registration deadline may register in person and then vote at one-stop voting sites in the person's county of residence during the one-stop absentee voting period (October 18-November 3). In order to register during a one-stop period, the applicant must show acceptable proof of name and residence in the county.

**Thursday, October 18, 2012** – One-Stop absentee voting begins. One-Stop voting will take place at the Board of Elections office at 140 Main Street. We will be open Monday through Friday from 8:00 am – 5:00 pm (October 18 through November 2) and 8:00 am – 1:00 pm on Saturday

November 3.  
**Saturday, November 3, 2012** - One-stop absentee voting ends at 1:00 pm

**November 3, 2012** - One-stop absentee voting ends

**November 5, 2012, 5:00 pm** - Absentee ballots must be received in CBE office by 5:00 pm

**November 6, 2012 - General Election Day - polls open 6:30am - 7:30pm**

**Prevention**

**Q. What can I do to reduce my risk of becoming infected with West Nile virus?**

A. Here are preventive measures that you and your family can take:

Protect yourself from mosquito bites:

Apply insect repellent to exposed skin. Generally, the more active ingredient a repellent contains the longer it can protect you from mosquito bites. A higher percentage of active ingredients in a repellent does not mean that your protection is better—just that it will last longer. [Click here for more on insect repellent active ingredients.](#) Choose a repellent that provides protection for the amount of time that you will be outdoors.

○ Repellents may irritate the eyes and mouth, so avoid applying repellent to the hands of children.

○ *Whenever you use an insecticide or insect repellent, be sure to read and follow the manufacturer's DIRECTIONS FOR USE, as printed on the product.*

For detailed information about

using repellents, see the [Insect Repellent Use and Safety](#) questions.

○ Spray clothing with repellents containing permethrin or another EPA-registered repellent since mosquitoes may bite through thin clothing. Do not apply repellents containing permethrin directly to exposed skin. Do not apply repellent to skin under your clothing.

○ When weather permits, wear long-sleeved shirts and long pants whenever you are outdoors.

○ Place mosquito netting over infant carriers when you are outdoors with infants.

○ Consider staying indoors at dawn, dusk, and in the early evening, which are peak mosquito biting times.

Install or repair window and door screens so that mosquitoes cannot get indoors.

Help reduce the number of mosquitoes in areas outdoors where you work or play, by draining sources of standing water. In this way, you reduce the number of places mosquitoes can lay their eggs and breed.

● At least once or twice a week, empty water from flower pots, pet food and water

dishes, birdbaths, swimming pool covers, buckets, barrels, and cans.

● Check for clogged rain gutters and clean them out.

● Remove discarded tires, and other items that could collect water.

Be sure to check for containers or trash in places that may be hard to see, such as under bushes or under your home.

Note: Vitamin B and "ultrasonic" devices are NOT effective in preventing mosquito bites.

**Q. Is there a vaccine against West Nile encephalitis?**

A. No, but several groups are working towards developing a vaccine.

**Q. Where can I get information about the use of pesticide sprays that are being used for mosquito control?**

A. The federal agency responsible for pesticide evaluation is the Environmental Protection Agency (EPA). [See the EPA Web site](#) for detailed answers to the questions about pesticides used for mosquito control.

Good news!

In September, United Way of Caswell County (UWCC) will be launching its first workplace campaign, the United Way of Caswell County Community Impact Campaign, in many years.

*"We have a United Way?"*

YES! UWCC has been working quietly behind the scenes since 1992 to help local agencies secure additional funding for their programming. For the most part, UWCC has done this work without a staff or an office, which is why you may not have noticed their presence.

As you probably know, 72% of the county's workforce works outside of the county. Some of those people participate in United Way campaigns in those areas. For example, someone working for a plant in Greensboro may give to United Way there, but designate Caswell. When this money goes to United Way of Greensboro, they turn around and send it to UWCC, who in turn, allocates it out to agencies.

This year, UWCC is anticipating nearly \$15,000 will be received from other United Ways and Corporate contributions from outside Caswell County. Those funds have already been allocated among 6 local agencies, including: Caswell Family Medical Center; Caswell 4-H; Caswell Senior Center; Caswell Partnership for Children; Caswell Parish and the Old North State Council, Boy Scouts of America.

The Board of Directors for UWCC wants to be able to do more to help those local agencies and others. They are in the process of trying to secure grant funding for UWCC to hire staff and serve as a central hub for the community - an agency that can help folks find the help they need and that can help local agencies work together to find more resources through grants and contributions to help them meet the growing need here in the county.

UWCC is working to mobilize the community by helping people take collective action to create positive, lasting change, but they need your help.
