

ORDINANCE NO. 2

AN ORDINANCE TO PROMULGATE RULES AND REGULATIONS PERTAINING TO THE COLLECTION AND DISPOSAL OF GARBAGE AND REFUSE FOR CASWELL COUNTY, THE ISSUANCE OF PERMITS AND LICENSES FOR THE COLLECTION THEREOF AND THE IMPOSITION OF PENALTIES AND FINES FOR VIOLATION.

ARTICLE I. PERMITS

Section (a): The collection and disposal of garbage and refuse within the areas of Caswell County outside the incorporated municipalities therein shall be effected by private contract collectors who shall be licensed upon application by the issuing of permits by the Caswell County Board of Commissioners.

Section (b): These permits shall be renewed annually effective the First Monday of July of each year and a charge of Fifty Dollars (\$50.00) shall be made for the issuance thereof. Evidence of the permit and the permit number must be appropriately displayed on each vehicle used by licensed collectors in the collection and disposal of garbage and refuse.

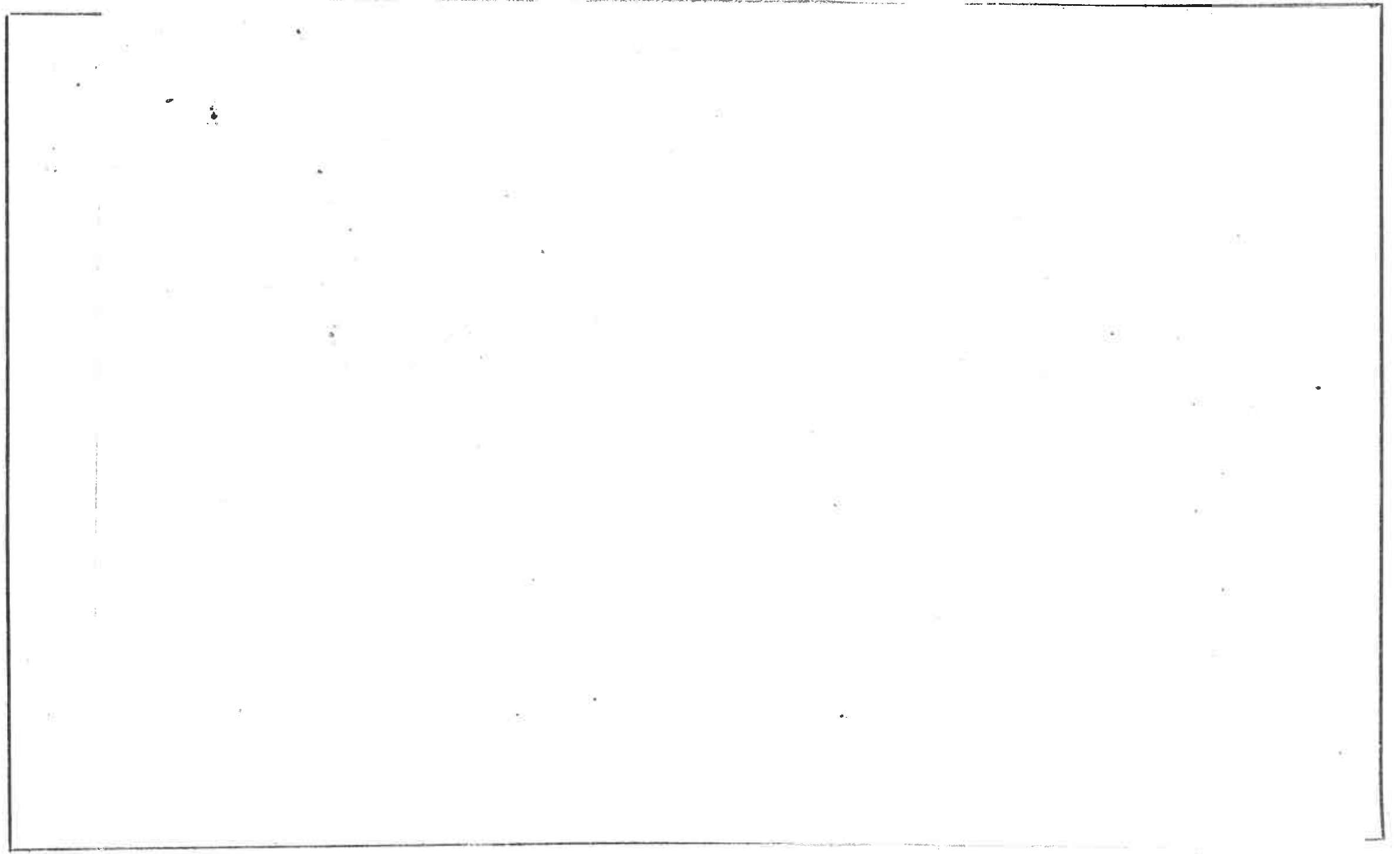
Section (c): Permits shall be valid only for collection in the geographic area specified in the permit. No permits for areas being served by licensed collectors shall be issued unless the Board of County Commissioners, upon investigation, shall find an additional garbage collector or collectors needed; at which time agreement must be reached with the existing collector from whose territory the new area is created.

Section (d): No person shall be allowed to operate as a collector of garbage without a permit from the Caswell County Board of Commissioners; provided that no permit shall be required for any person to dispose of refuse from his own residence or business establishment.

Section (e): No permit shall be issued without the recommendation of the County Sanitarian that such applicant is able to comply with the requirements of Article IV.

ARTICLE II. COLLECTION ROUTES

Collection territories shall be assigned to each collector upon issuance of a permit by the Caswell County Commissioners and each collector shall be under obligation to serve all customers within that territory.



**ARTICLE III. FEES**

Section (a): The maximum garbage collection fees for residences shall be Four Dollars (\$4.00) per month, payable in advance, which will provide for once-a-week pickup. Special arrangements for which fees may be collected to include additional weekly collections, special trash hauling contracts or other special agreements may be made by the collectors with clients.

Section (b): Pickup fees for commercial or business establishments shall be determined on a reasonable basis through mutual agreement of the parties with the exception of service rendered to County Governmental Offices, agencies and schools in which a minimum fee of Five Dollars (\$5.00) per pickup will be levied, if waste containers are provided by said County.

Section (c): The private collector may discontinue service at any time if and when said customer shall be at least thirty days in arrears in payment for such services.

**ARTICLE IV. STORAGE, COLLECTION, TRANSPORTATION, AND DISPOSAL OF GARBAGE**

No person, firm or business shall store, collect, transport or dispose of garbage or refuse in any manner other than as provided by the rules and regulations of the North Carolina State Board of Health and the District Board of Health. The County Sanitarian/promptly notify the Board of Commissioners whenever he finds any non-compliance with or violation of these Board of Health Regulations.

**ARTICLE V. LIABILITY**

Anyone receiving a permit to collect garbage or refuse from the Caswell County Commissioners shall submit to that body, for its approval, a good and sufficient bond or liability insurance, covering such damage as may be done to the premises of anyone upon which he may enter for such collection, in the sum of not less than One Thousand (\$1000.00) Dollars.

**ARTICLE VI. REVOCATION OF PERMITS AND APPEALS**

Whenever the Board of Commissioners find that these regulations are not being complied with, or whenever the Health Director finds that Article IV is not

being complied with, the Board or the County Sanitarian, respectively, shall give notice in writing to such refuse collector that unless the practices or conditions are corrected within 30 days, the permit shall be revoked. At the end of the 30 day period, the Board or the County Sanitarian respectively, shall make another finding and if the practices or conditions have not been corrected, notice shall be given in writing to such refuse collector that his permit has been revoked. Upon receipt of this notice, such refuse collector shall immediately cease to collect, transport or dispose of refuse until such time as his permit has been reinstated or a new permit obtained. For the purposes of this article, the County Sanitarian shall act as agent of the Board of Commissioners.

#### ARTICLE VII. APPEALS

Any person aggrieved by any action of the Board of Commissioners or County Sanitarian in carrying out these regulations may appeal in writing to the Board of Commissioners for a hearing. No such hearing shall be held unless written petition therefor shall be filed in the office of the Clerk of the Board of Commissioners on or before the tenth day following the action aggrieved of. The hearing shall be held as soon as practicable after receipt of the written petition. After such hearing, the Board of Commissioners may approve or reverse the action aggrieved of, or may take such other action as it deems appropriate, depending upon its findings as to whether or not these regulations have been complied with.

#### ARTICLE VIII. VIOLATIONS

If any person shall violate the rules and regulations made herein by the Caswell County Board of Commissioners, he shall be guilty of a misdemeanor and, upon conviction, shall be fined not exceeding Fifty (\$50. 00) Dollars or imprisoned to not exceeding thirty (30) days, as provided by section 14-4 of the General Statutes of North Carolina.

#### ARTICLE IX. EFFECTIVE DATE

This ordinance shall be in effect on and after the First day of July, 1974.

ARTICLE X. PUBLIC ADDRESS

Each collector duly licensed in accordance with the beforementioned provisions of this ordinance by the Caswell County Board of Commissioners shall establish and maintain a public address. Such address shall constitute a public mailing address and telephone listing. Said address to be adequately advertised and publicized so as to be readily accessible to the general public of Caswell County.

ARTICLE XI. NOTICE OF NON REAPPLICATION

Each collector duly licensed in accordance with the beforementioned provisions of this ordinance by the Caswell County Board of Commissioners shall give notice to said board of his intention not to seek renewal of his permit. Said notice to be given at least ninety (90) days prior to the First Monday of July.

ARTICLE III. FEES

Section (b): Pickup fees for commercial or business establishments shall be determined on a reasonable basis through mutual agreement of the parties with the exception of service rendered to county governmental offices, facilities, agencies, and schools in which a maximum fee of five (\$5.00) per pickup will be levied if waste containers are provided for said offices, facilities, agencies and schools by the said county.



Section (b): Pickup fees for commercial or business establishments shall be determined on a reasonable basis through mutual agreement of the parties with the exception of service rendered to County Governmental offices, agencies and schools in which a maximum fee of Ten Dollars (\$10.00) per pickup will be levied. If waste containers are provided by said County.

Special arrangements for which fees may be collected to include additional weekly collections, special trash hauling contracts or other special agreements may be made by the collectors with clients.

Section (b): Pickup fees for commercial, business, and County governmental offices, agencies, and schools shall not exceed Nine Dollars (\$9.00) for four cubic yard boxes, Eleven and one-half Dollars (\$11.50) for six cubic yard boxes, and Fifteen and one-quarter Dollars (\$15.25) for eight cubic yard boxes.
